SUMMARY

I grew up on a dairy-row crop farm in South Carolina. I obtained a B.S. and M.Sc. in Agricultural Economics from Clemson University. After working briefly at the USDA Foreign Agricultural Service, I missed doing research and decided to return to school. I obtained a Ph.D. in Economics and Statistics from North Carolina State University with a field in International Trade.

I began my academic career as an Assistant Professor of International Trade and Econometrics at the University of Tennessee, followed by 12 years on the faculty at Texas A&M University, where I progressed from Assistant to Full Professor in the Department of Agricultural Economics. While at TAMU, my research interests shifted toward food and health economics, leading to my recruitment in 2007 by Virginia Tech's Department of Agricultural and Applied Economics as part of an obesity cluster hire.

Over the course of my career, I have published 88 refereed journal articles (h-index 28, i10-index 57) across 41 different journals, co-authored two books, delivered over 60 invited talks and 50 peer-reviewed presentations, and been cited in over 25 popular press interviews. I've secured 24 grants totaling \$4.6 million (2024 dollars), taught 16 different courses, chaired 17 graduate committees, and served on 40 additional M.Sc. and Ph.D. committees. My work has been recognized with best paper awards and the AAEA Quality of Communication Award.

My professional service includes, among other activities, being an editor for three academic journals, multiple editorial councils, and leadership or membership in several national committees. I have reviewed for 33 journals, ranging from *American Economic Review* to *Water Resources Research*. At the university, college, and department levels, I have served as a chair and member of multiple committees such as being a member of the faculty senate, chairing the college promotion and tenure committee, director of the graduate program, and currently the interim department head.
