### PROFESSIONAL PROFILE

Teaching has been an important part of my professional career. In nineteen years at the university, I have had over 6800 students in my 100-plus classes. Classes taught have included 5310 Agricultural Policy; 4204 Food and Agricultural Policy; 4604 Agricultural Property Law; 4604 Real Estate Law and Appraisal; 3604 Agricultural Law; 3750 Agricultural Law I; 3760 Agricultural Law II; 3314, 3700 Environmental Law; 1001 Agricultural Economics; AT 0244 Ag Tech Law and Taxation; 4754 Real Estate Law, 4764 Real Estate Appraisal; and University Honors 3000 Food/Drug Law. This course load is two to three times most faculty in the department and has consisted of four to five courses per year. In addition, I have coordinated the undergraduate program of 90 undergraduate students. This has included major efforts in recruitment and placement as well as 74 assigned advisees. During the school term, I average 25 student office contacts per week. The department has elected me to the Department Advisory Committee. The department asked me to chair the Undergraduate Committee for ten years. I have coordinated the undergraduate program for ten years.

My colleagues have elected me to represent them on, and as chair of, the College Curriculum Committee [Undergraduate Studies and Affairs Committee] and the university curriculum committee, the Commission on Undergraduate Studies (3 years). My university colleagues elected me to the Commission on Student Affairs, the University Core Curriculum Committee, and as an officer of the Faculty Senate three times. I currently serve as chair of the Faculty Review Committee. The Provost appointed me to the committee to review the general education requirements of the university. I also served on the University Course Criteria Committee, approving university course offerings. All of these positions have allowed me to know how the academic and student life areas of the university work. All of these positions have allowed me be a better advisor, teacher and professional. These opportunities have allowed me to serve as a role model for students in service and to improve the academic life of the university. The President has asked me to serve as advisor to the University Honors system for 1997-2000 and 2000-2003. Colleagues have elected me to serve as president of the CALS Faculty Association and President of the University Senate.

I have served as advisor to the Undergraduate Agricultural Economics Club for four years and been an advisor to Student Legal Services.

In addition to the academic program, I have taught the farm tax section of the Annual Farm and Small Business Tax Conference of which I direct. This conference raises \$50,000 per year for the department and \$225,000 for the University. The money funds graduate and undergraduate students to support my teaching, research and public service activities. I have published with both undergraduate and graduate students.
